New research shows bacteria form species and maintain cohesion through frequent DNA exchange (homologous recombination). This "sexual" process reinforces distinct species boundaries, overturning previous assumptions that bacteria don't form species. The findings have major implications microbiology, for medicine, and environmental science.



Ancient Mantle Islands Found New research reveals two continent - sized "islands" deep within Earth's mantle. These ancient regions, at least half a billion years old, are hotter than their surroundings. The findings challenge the idea of a rapidly flowing mantle, suggesting less flow than previously thought. Seismologists earthquake used vibrations to "see" these hidden structures, like using X-rays.



DeepSeek Creates a Stir: China's AI Chatbot **Becomes a Global Talking Point**

hinese startup DeepSeek has recently created a stir in the global tech world with the success of its AI chatbot. The company has developed an effective AI model using low costs and minimal resources, which is challenging leading American Al models. DeepSeek's chatbot has reached the top position in the free apps category on the Apple App Store, leading to a decline in the shares of American tech companies. Nvidia's shares have seen a decrease of up to 17%. US President Donald Trump has called it a 'wake-up call' for the American tech industry. However, some tech experts, including Elon Musk, have expressed doubts about DeepSeek's claims. DeepSeek recently faced a cyber attack, after which it has temporarily limited the registration of new users.

Denmark urges EU support over Trump's

anish Prime Minister Mette Frederiksen met with European leaders in Berlin, Paris, and Brussels, seeking support against President Trump's threats to seize Greenland.

Trump expressed interest in acquiring the Arctic island, citing its strategic importance and natural resources, even suggesting military action. Frederiksen's tour followed growing European concern after a Nordic summit. German Chancellor Scholz emphasized that borders cannot be changed by force.



Trump Halts Foreign Aid Citing Wasteful Spending



President Trump's decision to halt all US foreign aid drew criticism, but White House Press Secretary Caroline Levitt defended the move, revealing that the Biden administration had allocated \$50 million for a condom distribution program. Levitt stated that the newly formed Government Efficiency (DOGE) Department and the Office of Management and Budget found that taxpayer funds were designated for condoms in Gaza. Calling it

an absurd waste of taxpayer money, she emphasized focus on responsible spending.

Supersonic Flights Near Reality with US Tests



upersonic flights may soon become Ja reality as two US aircraft are set for testing. Boom Supersonic will demonstrate its XB-1, while NASA tests the X-59. Successful trials could lead to commercial supersonic travel, with Boom already having over 130 orders. XB-1's flight aims to break the sound barrier, following decades since the Concorde, signaling a potential shift in air travel.

Ion Musk has addressed claims of being a time traveler, fueled by a 1953 sci-fi book predicting a Martian leader named "Elon." Musk jokingly tweeted about being a 5000-yearold alien time traveler, sarcastically expressing disbelief at why people doubt him. While likely coincidental, even the original German manuscript names Mars's leader "Elon," adding to the mystery. Musk, with his Martian colonization goals, is no stranger to such speculation.



ISRO Makes History with 100th Launch

he Indian Space Research Organisation (ISRO) successfully launched its GSLV-F15 carrying NVS-02 at 29th jan, 6:23 AM from Sriharikota, Andhra Pradesh. This marked ISRO's 100th launch from the country's space center. The GSLV-F15 is the 17th flight of India's Geosynchronous Satellite Launch Vehicle (GSLV) and the 11th with an indigenous cryo stage. It's also the 8th operational flight of the GSLV with an indigenous cryogenic stage. GSLV-F15's payload fairing is a metallic version with a diameter of 3.4 meters. According to ISRO, the launch place the NVS-02 satellite into will Geosynchronous Transfer Orbit, which will enhance India's regional navigation satellite system from 4 to 5 satellites.

Hospitals Halt Ayushman Bharat Over Unpaid Dues

round 600 private hospitals in Haryana threaten to halt Ayushman Bharat scheme services due to 400 crore rupees in unpaid dues by the central government. The Indian Medical Association (IMA) claims payments are pending since August 2024 and warns that hospitals will cease treatment under the scheme from February 3rd if the dues remain unsettled. BJP promises to implement the scheme in Delhi if elected.

Global Trust in Scientists Remains Strong



The study, published in Nature Human Behaviour, found that people believe scientists should play a more active role in society and policymaking. India ranks second in trust towards scientists, following Egypt, indicating strong faith in science, though influenced by education, income, and location.

Bird Flu Kills 33 Demoiselle Cranes in Jaisalmer



nird flu has caused the deaths of 33 demoiselle cranes (kurjan) in Jaisalmer, Rajasthan. The deaths, primarily in Degray Oran and Mohangarh areas, began on January 11th. Samples from Degray confirmed H5N1 avian flu, while 14 cranes falling mid-flight in Mohangarh are under investigation. The local veterinary department is following protocols, while a quick response team is monitoring the situation.

Most Rural **Indian Teens Use Smartphones**



SER 2024 reveals 82.2% of rural Indian teens (14-16) use smartphones, but only 57% used them for studies last week. 76% used them for social media. While most have access, few own phones. Boys are more likely to own smartphones and show greater digital skills than girls. Kerala leads in study-related

smartphone use.

India Faces Dual Threat: Severe Floods and **Drought in Several Districts**

new study reveals that 51 districts in India face severe flood risk, with 118 at high risk. Simultaneously, 91 districts are under severe drought threat, and 188 at high risk. The study, by CSTEP and IITs Guwahati and Mandi, identifies 11 districts in various states with high vulnerability to both floods and droughts. The report assesses the vulnerability of districts and potential damage caused by these disasters. It highlights that drought risk is widespread, affecting districts across 22 states, and that the risk is heightened when districts are vulnerable due to various factors.

BJP is India's **Richest Party**



JP, claiming to be the world's Dlargest party, is also India's richest, with over ₹7,000 crore in cash and bank balances, compared to Congress's ₹857 crore. BJP's 2023-24 Lok Sabha election expenses were ₹1,700 crore, a 60% increase from the previous year. Congress spent ₹600 crore, a three-fold rise. BJP received ₹1,685 crore in donations, double last year's.

It's not only an affordable mode of transport for the people of Kolkata, but it also helps the city remain free from atmospheric pollution. It has become so integral to the lives of Kolkata's people that there seems to be no point in commuting without a tram. Similarly, hand-pulled rickshaws have been associated with Kolkata, but they were deemed

inhumane because they were pulled by humans. Therefore, they were discontinued, but the memory still lingers in the hearts of Kolkata residents.

Bengali and Hindi cinema have presented trams in a new dimension. In films, trams are often depicted as special places where heroes express their love to their heroines. These scenes have turned trams into more than just a simple vehicle; they have become a symbol of the city's identity. The sound of tram bells, the rustling of its wheels, and the conversations of passengers on board all form an integral part of Kolkata's life. The experience of roaming the streets of Kolkata on a tram with discounted tickets during school days is one that cannot be expressed in words. Due to all of this, trams have become deeply embedded in life. Whenever any legal case related to trams comes up, it's not just an issue about a vehicle; it is related to Kolkata's heritage, its emotions, and its existence.

Political Clouds Over Trams

In January 2023, a bench of the Kolkata High Court, comprising Chief Justice T.S. Sivagnanam and Justice Hiranmay Bhattacharya, heard a public interest litigation. This petition was filed by an organization named 'People's United for Better Living in Kolkata' (PUBLIC). The petition alleged that the state government's process of bituminization (laying asphalt on roads) would lead to the removal of trams and possibly the sale of their depots to private companies. The petitioners stated that this decision was not based on any scientific study.

The petition cited examples of cities like London,







Paris, and Istanbul which have revitalized their tram networks. In such a scenario, removing trams from Kolkata is not only unethical but also impractical. It would impact not just the city's transportation but also the environment, public health, and social structure negatively.

Court's Concerns and State Government's Accountability

During the first hearing in May 2023, the petitioners' lawyer reminded the court that the government was celebrating the completion of 150 years of trams in Kolkata. The court also expressed surprise and asked why a heritage like the tram was being terminated. "It is a heritage, why do you want to end it? Why can't it be improved?" the court asked the state government.

The state government said that they were trying to modernize the trams. However, the court believed that before removing the trams, a detailed study of its impacts should be conducted. The court clearly ordered that no bituminization process should be carried out on the tram tracks until a decision is reached on the petition.

Tram Heritage and Kolkata's Culture

During the hearing of another petition in June 2023, the Kolkata High Court made this significant comment, "Trams are a part of Kolkata's heritage, and the state government has a duty to preserve this heritage not only for the present but also for future generations." The court also said that when the people of Kolkata take pride in Durga Puja receiving the UNESCO heritage tag, they should also take pride in the revival of tram services.

This statement from the court echoes the feelings of the people of Kolkata towards the trams. Trams are not just a vehicle; they are a symbol of Kolkata's culture and history. Ending their existence would not only mean eliminating a means of transportation but also extinguishing a city's soul.

Future Challenges and the Existence of Trams

As time progresses, the sound of trams on the streets of Kolkata is gradually diminishing. Currently, the tram network that once spanned 116.62 kilometers has been reduced to only 33.04 kilometers. The direction in which Kolkata's future will move is something only time will tell.

However, it is the responsibility of all of us to ensure that this heritage of Kolkata is preserved. What the outcome of the ongoing tug-of-war between the state government and the court will be is something interesting to watch. But whatever happens, the place of trams in the hearts of the people of Kolkata will always remain.

BJP secured 181. Following this defeat, Kejriwal began using religion and religious symbols to connect with the public and manipulate electoral calculations.

entirely free of corruption and based on public service, opposing traditional politics. However, in recent years, Kejriwal's politics have taken a new turn, which analysts define as a shift towards 'soft Hindutva.'

In a recent interview, Kejriwal portrayed himself as a devout follower of Hanuman, stating that he had worshipped Hanuman

since childhood. This is not the first time he has publicly shared his religious beliefs. 

Many analysts view Kejriwal's religious inclination as an example of 'soft Hindutva,' a result of the growing influence of Hindutva in Indian politics. There are seven Assembly seats in Delhi where Muslim voters play a decisive role, including Seelampur, Okhla, Mustafabad, Chandni Chowk, Ballimaran, Matia Mahal, and Babarpur. This change reflects his 'soft Hindutva' image, setting him apart from the BJP's more rigid Hindutva.

During the Delhi riots, Kejriwal avoided addressing the pain of the Muslim community, making it clear that he didn't want to lose his Hindu voter base. By distancing himself from the protests at Shaheen Bagh, he ensured

that his image didn't become that of a pro-Muslim supporter, allowing him to retain Hindu voters.

trying to create a balance where they can maintain trust between both communities.



hen we talk about quantum teleportation, the word "teleportation" may first bring to mind the characters from science fiction movies, who instantly travel from one place to another. However, this case is somewhat different. Quantum teleportation means transferring a quantum state from one location to another without physically sending it. This is based on the principle of quantum entanglement, where the states of two particles remain connected regardless of the distance between them. In the future, this technology will be used in quantum computing, cryptography, and other critical networking tasks. This experiment has made the process even more significant, as it has now been demonstrated that quantum signals can be transmitted within the same fiber alongside traditional optical traffic.

Key Features of the Experiment:

In this experiment, quantum teleportation was successfully carried out over a 30.2-kilometer-long optical fiber, which was simultaneously carrying traditional communication traffic. The fiber was transmitting classical traffic at 400 gigabits per second. The quantum state was successfully transferred from one location to another, using a crucial technique known as 'Bell State Measurement.' The most remarkable aspect of this experiment is that the guantum signal was transmitted in such a way that it wasn't affected by the high-power classical signal. To understand this, we can draw an analogy with the mythological tale of the 'Samudra Manthan,' where both nectar and poison were churned together but handled differently. Similarly, this experiment discovered a way to manage both guantum and traditional signals together.

The Convergence of Quantum and Traditional Networks:

Currently, the internet networks we use are based on optical fiber, which transmits data using light waves to reach from one location to another. However, to enable quantum networks, we need a network that can also transmit quantum signals. Until now, such networks needed to be built separately, resulting in high costs. But this experiment has proven that guantum and traditional signals can be sent through the same optical fiber, providing significant cost and infrastructure benefits. It's like having bicycles and high-speed cars travel together on the same road, but with both having a safe journey. Scientists have successfully overcome this challenge. They solved an issue known as 'Spontaneous Raman Scattering,' which can occur from high-power classical



n the afternoon of July 16, 2024, when student leader Abu Saeed was shot and killed by the police in Bangladesh's Rangpur district, a completely different scene was unfolding in Dhaka. At the Ministry of Fisheries and Livestock, senior leader and minister of the Awami League, Prime Minister Sheikh Hasina's party, Abdur Rahman, was comfortably enjoying a poetry reading by a local poet in his office. In a video, he was seen sitting back in a chair, resting his hand on his right cheek, and enjoying the poetry. When he learned about Saeed's murder and the growing protests, he dismissed it, saying, "Nothing will happen; the leader [Hasina] will handle it."

This scene, where one part of Bangladesh's streets was engulfed in bloodshed while a minister remained calmly seated in a safe

position, became a symbol of deep inner conflict for the country's citizens. It highlighted how disconnected the top leadership of the Awami League had become from the issues and discontent rising among the people.

Just three weeks later, a fierce studentled movement overthrew the Sheikh Hasina government. The protests, which began on July 1, led to 834 deaths and left over 20,000 people, including women and children, injured. The movement against Hasina's government grew so large that on August 5, 2024, Sheikh Hasina had to flee to India. This event marked the end of her 16year rule.

Now, five months later, the situation for the Awami League has become just as difficult. Instead of acknowledging their mistakes, the party's top leadership has been avoiding responsibility by labeling these events as part of a foreign conspiracy. The party's General Secretary, AFM Bahaauddin Nasim, blamed the movement on international conspiracies, saying, "We have been victims of an international conspiracy, and proof will be found soon." This statement clearly demonstrated the party leaders' insensitivity and complete disconnection from the people.

Deep contradictions have now emerged within the Awami League. On one hand, the top leaders claim that they had acted in the right direction, while on the other hand, mid-level leaders and

party workers are frustrated that the leadership has completely cut itself off from the people. Many workers have become so disheartened that they are contemplating leaving politics altogether.



A senior student leader expressed his frustration, saying, "When we planned to overthrow the Hasina government, we thought our leaders would help us. But when the time came, our leaders abandoned us and fled." Members of the Bangladesh Chhatra League now feel isolated.

There has been no apology or remorse from the senior leaders of the Awami League regarding the party's actions so far. Instead, party spokespeople have labeled the student movement as terrorist activity and accused it of being part of pro-Pakistan forces. This statement from the party leaders is only escalating public anger. Political analysts believe that such strategies have failed to improve the party's image.

The Awami League now faces a difficult road to re-establish itself. To revive its old identity, the party will have to work hard. The biggest challenge in this effort will be facing the criticism coming from within the party and restoring trust among the public. Political analysts believe that if the party takes responsibility for its leaders' actions and takes steps in the right direction, it can regain its lost support.

Political analyst Ali Riaz states, "The Awami League needs to apologize for its mistakes and take steps towards change in its current leadership. Only if these conditions are met, can the party's future be secured."

The path to rebuilding for the Awami League is difficult, but it is not impossible. The party will need to bring about changes in its policies and regain the lost credibility among the people. If the party reforms its leadership and structure, it may be in a stronger position to participate in the next elections. But the biggest challenge will be how much the party is willing to self-reflect and improve on its past actions.

n October 7, 2023, the war between Israel and Hamas not only shook the political landscape of the Middle East but also raised global concerns about peace and security. This war has taken steps towards a peaceful resolution after 15 months, but its outcomes remain difficult to understand. Has Israel truly achieved its military and strategic goals, or is this just a temporary success? The answer to this question is not only important from a military perspective, but also from political, diplomatic, and humanitarian angles.

Definition of Victory and Israel's Objective:

Victory is not limited to military success; it encompasses achieving strategic objectives, regional stability, and hopes for long-term peace. Israel had clearly stated its objective in the war

that began on October 7 was to "destroy Hamas," a terrorist organization ruling the Gaza Strip. While the Israeli military killed the top leaders of Hamas and destroyed its military infrastructure, the organization's strength and roots are so deep that it has resurfaced.

srael's goal in the war was not only to destroy Hamas but also to ensure its national security. Prime the region into a severe humanitarian crisis. The Minister Benjamin Netanyahu viewed this war as a victory from a national security perspective and declared that "our armies have destroyed Hamas and all our war objectives have been achieved."

Netanyahu's statement supports the idea that Israel effectively demonstrated its military strength and succeeded in reducing the threats within its borders.

During the war, Israel's forces targeted several key military sites, including weapons storage, rocket launch pads, and other strategic locations. However, Israel did not have a plan in place to ensure permanent peace in Gaza, which shows that the results of military action may not be secure in the long term. Additionally, while Israel made efforts to minimize harm to civilians during the war, the significant loss of life among Gaza's civilians raised questions about human rights and war crimes.



Many media sources suggest that this would be negative for the environment, economy, technology, and science, but several analyses contradict this by stating that although Trump's return may be a blow to many countries and may cause them harm, he will undoubtedly achieve his goal of making America great again. But will he, really?

onald Trump, who took office as the 47th President of the United States on January 20, 2025, for his second term, emerges as a staunch nationalist and right-wing leader on the global stage. His rise will provide a positive boost to right-wing political forces around the world, and once again, the world will witness nationalism being raised in various forms across different nations.

Upon taking the oath, Trump immediately passed a series of executive orders covering topics ranging from trade, immigration, and U.S. foreign aid to demographic diversity, civil rights, and the appointment of federal employees. Some of these have an immediate political impact on the U.S., while others are more symbolic in nature.

Trump's order calls for suspending the US refugee admissions program until January 27, 2025. This suspension will continue until a review of the immigration system is completed.

The broad scope of the Republican president's actions reflects many of his electoral promises and his resolve to steer the country quickly towards a right-wing direction, consolidating executive power in the Western region. However, the impact of these actions will not be limited to U.S. borders but will equally affect the rest of the world.

Trump's proposed immigration and border security program aims to bring sweeping changes to the American political and social structure. This program not only tightens current immigration laws but also seeks to redefine national security,

military intervention, and the criteria for U.S. citizenship. His approach presents the situation as an "invasion" at the U.S. borders, focused on illegal immigration and immigration control.

Trump's Military Use: The Challenge to Posse Comitatus Trump's orders include provisions to involve the U.S. military in immigration control,

> deploying the Ready Reserve and National Guard for border security. Additionally, military properties will be used for detention facilities, land and air transport, and logistics services. This step conflicts with the 1878 Posse Comitatus Act, which generally limits the use of military personnel in domestic law enforcement functions. Trump has linked it to national security, and it is

being viewed as a military step that strengthens his presidential powers.

Redefining Birthright Citizenship: A New Interpretation of the 14th Amendment Trump's immigration orders redefine birthright citizenship under the 14th Amendment. Now, a child born in the U.S. will only be considered a citizen if their parents are legal permanent residents of the U.S. This order is facing legal challenges in federal courts, but if enacted, it could affect the citizenship status of millions.

Suspension of the Refugee Program and a New Screening Process Trump's orders include



suspending the U.S. refugee entry program until January 27, 2025, pending a review of the immigration system. Additionally, a stricter vetting process will be implemented for those seeking visas or other immigration benefits. This process will be based on standards used during Trump's first term, with a focus on national security.

Construction of the U.S.-Mexico Border Wall and Security Measures Trump has prioritized the construction of a wall and other barriers on the U.S.-Mexico border. Termination of the Family Reunification Program The family reunification program that brings citizens from Cuba, Haiti, Nicaragua, and Venezuela and their family members to the U.S. will also be terminated. The Trump administration aims to focus on individuals undergoing legal immigration processes instead.

Revocation of Biden's Policies on Climate Change and Global Migration Trump also plans to revoke Biden's order, which planned migration patterns due to the effects of climate change. According to Trump, this policy is unnecessary, and instead, national security should be prioritized.

Trump has also proposed denying federal funds to non-governmental organizations that assist illegal immigrants and plans to withhold federal funding from "sanctuary" cities that fail to enforce federal immigration laws.

Transgender and Civil Rights

A 60-day deadline for policies and contractors associated with DEI shows the administration's urgency. Moreover, the cancellation of Biden's directives on racial, ethnic, and LGBTQ rights

sends a clear message that the Trump administration emphasizes traditional values and structures, particularly on issues of gender and gender identity. This represents a major setback for the LGBTQ community, which had benefited from many rights and inclusive policies during the Biden administration.

Additionally, the recognition of only two genders in government documents and the rejection of the concept of 'gender identity' underscores the administration's stance that it views gender as biologically and traditionally defined. This will also impact schools and prisons, where inclusive provisions for transgender people will be removed.

Federal Employees and Government Structure

An analysis of this policy proposal shows the Trump administration's focus on government structure and federal employees. The most prominent aspect is the establishment of a 'Government Efficiency Department,' which will be led by Elon Musk. Under

Musk's leadership, this department aims to cut federal programs and spending, demonstrating the administration's priority to reduce expenditures and improve government efficiency.

Each agency head will be required to form a 'DOGE Team,' which will work with Musk. This centralized approach seeks to inspire various government agencies toward private sector efficiency and performance. The restriction on federal hiring, with certain exceptions, is part of the effort to limit the number of federal employees and cut government spending. However, this restriction will not apply to crucial areas such as border security, immigration, and military services, ensuring the protection of national security and interests.

The restriction on federal regulations, particularly in agencies where Trump-appointed officials are not present, is an attempt to further control the administration's priorities and approach.

Additionally, the directive for all federal employees to return to full-time work and the review of Senior Executive Service (SES) officials is a step towards more transparent control by the administration. Under this policy, SES officials must remain loyal to the president's policies, and failure to do so could result in dismissal.

Moreover, prioritizing 'dedication to the Constitution' in federal appointments reflects the administration's belief that those working in government should be committed to American ideals.

In summary, this policy approach centers on government efficiency, control, and national security, while signaling changes in traditional hiring and structures.

Healthcare

The Trump administration's healthcare policy analysis reveals several key aspects that diverge from Biden's priorities. Trump's plan focuses on reversing Biden's directives aimed at simplifying Medicaid enrollment, guaranteeing insurance coverage under the Affordable Care Act, and efforts to reduce drug costs. Biden's policies were



centered on making healthcare more accessible and reducing medical expenses.

However, Trump's proposal does not eliminate critical policies such as Biden's \$35 monthly cap on insulin or the annual \$2,000 out-of-pocket limit for Medicare prescription drugs. These policies are part of laws passed by Congress and cannot be overturned by the Trump administration, indicating that some of Biden's significant healthcare policies will remain in place.

Additionally, Trump's policy focuses on reversing many of Biden's orders and directives related to COVID-19. This measure aims to undo the strict regulations implemented by Biden during the pandemic, which had a significant impact on social and economic life. This step signals a move towards a more normal state, where the COVID-19 guidelines will be relaxed in favor of a more flexible approach.

Trump administration policies point in the direction of a freer market and less government intervention, limiting Biden's reforms in healthcare. However, with some major drug price controls and Medicare-related policies unlikely to change, it is also clear that not all major changes are possible immediately.

Nationalism and Symbolism

Donald Trump's emphasis on nationalism is clearly visible in his policies and symbolic decisions. One example of this is his decision to restore the name of Mount McKinley in Alaska, which honors America's 25th President, William McKinley, Former President Obama had renamed the mountain Denali, which was historically the name given by indigenous tribes. Trump's decision behind this was to recognize America's national pride and its historical leaders. However, his order did not change the name of Denali National Park and Preserve, indicating respect for the historical heritage of local tribes.

Additionally, Trump demanded new architectural

Thus, Trump's policies in healthcare signal a shift toward a free market with less government intervention, while also acknowledging that some major changes will not be immediately possible due to the constraints of existing laws.

standards for federal buildings to preserve and honor America's classical and traditional architectural heritage. His intention behind this order was for federal buildings to reflect American cultural heritage and beautify public spaces. This is another symbolic step of Trump's nationalist ideology, highlighting his desire to preserve America's regional and traditional heritage.

Death Penalty and Crime Policy

Trump's approach is clearly biased in favor of law and order. His directives ordered the Attorney General to review whether the 37 federal inmates, whose death sentences were commuted to life imprisonment by Biden, could be prosecuted again for capital crimes in state courts. Additionally, he directed that "all necessary and legal measures" be taken to ensure the availability of suitable drugs for lethal injections.

A significant aspect of Trump's policy was his order to overturn Supreme Court rulings that limited the use of the death penalty in state and federal territories. He also encouraged state and district attorneys to seek the death penalty in all possible cases. This reflects his tough stance on law and order and supports his stringent policies on crime.

Capital Riot and 2020 Election

Trump's decisions after the Capitol riots clearly reflect his political ideology and commitment to his supporters. He announced the commutation of sentences for hundreds of people convicted for the January 6, 2021, Capitol attacks and granted them full pardons. His justification was that the attacks were a result of electoral fraud against him, which he described as the "weaponization of the federal government."

He directed the Attorney General and other officials to review the investigations and enforcement actions taken during Biden's tenure to ensure that no unjust actions were taken against his supporters. Additionally, he ordered an investigation into the U.S. government's behavior with social media platforms, which Trump characterized as censorship efforts. This investigation also directed for "appropriate corrective actions" to be recommended.

Trump revoked the security clearances of 50 individuals who had cooperated with Biden's 2020 campaign on the Hunter Biden laptop case. This decision was made by accusing intelligence officials of allegedly trying to influence the election. Trump ordered the Director of National Intelligence and the CIA Director to present a report within 90 days recommending disciplinary actions.

Conclusion

Donald Trump's policies are based on nationalism, crime control, and controversies surrounding the 2020 election. He restored the name of Mount McKinley and emphasized the preservation of federal building architectural standards with the aim of honoring American heritage and traditions. He also sought to reintroduce the death penalty and promoted tough policies on law and order. Regarding the Capitol riots and the 2020 election, Trump sought to protect his supporters and called for a review of Biden administration policies. These decisions clearly reflect Trump's nationalist stance and tough approach to law and order.

TRUMP **AMERICA FIRST**

OR THE PATH OF **CONTINUITY?**

In this article, we will compare the foreign policies of Trump and Biden and analyze what changes and continuities we might witness during Trump's second term.





n January 20, 2025, U.S. President Donald Trump returned to power. Speculation is rife about the direction of his new foreign policy across the globe. While his predecessor, Joe Biden, emphasized democracy and global cooperation, Trump prioritized the "America First" policy. There is a clear distinction between the two leaders' approaches, yet some areas of continuity remain. Even though each president brings their personal perspective and style, this continuity largely stems from the geographical, economic, and political realities of the United States. Regardless of who is president, the U.S. follows a steady path to protect its national interests and values.

Key Differences in Trump and Biden's Foreign **Policies**:

During Biden's tenure, the U.S. supported Ukraine, vowed to defend Taiwan, focused on climate change, and promoted democratic values. He also prioritized international alliances and global coalitions against China. His administration ensured that the U.S. retained its global leadership, rejoining the Paris Climate Agreement.

In contrast, Trump had several notable differences in his approach. He guestioned support for Ukraine, hesitated on the Taiwan issue, dismissed the threat of climate change, and showed less interest in promoting human rights and democracy. Trump criticized U.S. allies for not contributing enough to defense spending and took a tough stance against China. His belief was that the U.S. should prioritize its interests first and ensure that any global cooperation brings tangible benefits to America.

Continuity Between Trump and Biden's Foreign **Policies**:

Despite significant differences in their foreign policy approaches, there are areas of continuity. For instance, Biden recognized China and Russia as America's top global competitors, which was a key part of Trump's policy. Additionally, Biden maintained the tariffs and tech controls imposed on China during Trump's administration. Biden also adhered to the agreement made by Trump for the withdrawal of U.S. troops from Afghanistan and provided lethal aid to Ukraine, as Trump had done.

Moreover, Biden continued the Abraham Accords, a significant diplomatic success of the Trump administration. He sought to strengthen U.S. relations with Saudi Arabia, an issue that had been important during Trump's tenure. Thus, while there may be differences in style between Biden and Trump, continuity in core policy areas can still be observed.

Potential Changes in Trump's Second Term:

In Trump's second term, we may witness some important changes. Firstly, relations with U.S. allies may take a harsher tone. In his first term, Trump claimed that many countries had benefited from U.S. security for free, and he aimed to change this. Additionally, his focus has always been on trade deficits and economic competition, particularly with China. This policy might become even stricter during his second term.

Regarding China, the Trump administration is likely to view it as a major challenge to U.S. economic and security interests. To counter China's growing influence in the Indo-Pacific region, Trump may work on strengthening alliances with U.S. partners like India, Japan, and Australia. An example of this would be defense agreements like Quad and AUKUS, initiated during Trump's time and furthered by the Biden administration.

Differences and Similarities in Style:

The stylistic difference between Trump and Biden's foreign policies is evident. Trump is seen as a leader who makes unilateral decisions with less dialogue with allied nations, whereas Biden emphasized consultation and communication with partners.

Trump often clarified his policies via Twitter and social media, while Biden adopted more traditional diplomatic methods. Nonetheless, the Biden administration has also made unilateral decisions in several instances, such as imposing export controls on Chinese tech companies.

The Stability of Foreign Policy:


Despite changes in administrations, certain areas of foreign policy remain consistent. For example, President Obama criticized George Bush's "war on terror," but he carried out military actions in more countries than Bush. Similarly, Donald Trump criticized NAFTA and the U.S.-Korea Free Trade Agreement during his campaign, but as president, he signed revised versions of these deals. This demonstrates that even though presidential candidates promise policy changes during their campaigns, many areas remain consistent regardless of who occupies the White House.

Stable American Interests:

Several factors in American foreign policy remain stable over time, such as preventing a hostile power from dominating Eurasia, protecting maritime freedom (which is crucial for trade), maintaining the stability of energy supplies from the Middle East, and supporting Israel. These stable interests result in less variability in American policy, which remains more or less consistent under every president.

Regular American Intervention:

There is continuity in several areas of American foreign policy. For example, the policy of bringing



political change in Cuba has been ongoing since President Eisenhower. The policy of encouraging NATO countries to spend more on defense has continued since President Kennedy. Similarly, the U.S. has used military force to protect its interests in the Middle East, a practice that began under President Jimmy Carter and continues to this day. Additionally, negotiations with North Korea, the Israel-Palestinian peace process, and missile defense plans have all remained consistent across American administrations.

Role of Congress:

The U.S. Congress plays a crucial role in maintaining stability in foreign policy. For instance, after the U.S. recognized Beijing over Taiwan, Congress passed the Taiwan Relations Act, ensuring support for Taiwan. Similarly, when President Carter planned

to withdraw U.S. forces from South Korea in 1977, Congress intervened. Likewise, when Trump showed warmth towards Russia, Congress enforced Obamaera executive orders in legal form.

Continuity in International Relations:

The framework of American foreign policy ensures that key foreign alliances are always maintained. For example, despite different approaches under various administrations, U.S. relations with Israel, Saudi Arabia, and China have remained intact. Whether it was Biden or Trump, the U.S. has always viewed China as a global challenge and maintained its strategic ties with Saudi Arabia.

Impact of Presidential Personality on Foreign Policy:

The article also highlights that the president's

personality and leadership style impact foreign policy. For example, while there may have been differences in the foreign policies of Obama and Trump, the core policies they adopted weren't vastly different. Both Trump and Biden emphasized the power of personal relationships, although their approaches were different. Trump utilized social media, while Biden followed more traditional diplomatic methods.

Limits to Policy Change:

Policy of Avoiding Conflict:

Lastly, the foreign policy sentiment remains that U.S. administrations try to avoid military conflicts. Just as Biden tried to avoid military conflict in Russia, Afghanistan, and the Middle East, Trump also attempted to avoid such conflicts in his strategy.

TRUMP 2.0 **Economic Growth Through Clean Energy** Is Trump Ready?

The widespread wildfires in Los Angeles are yet another horrific example of the rapidly growing and deadly impacts of climate change. Those who deny climate change are misguided and could cause immense environmental damage, especially if they hold powerful positions, like Trump, who could hinder efforts to prevent or mitigate the damages caused by climate change. Trump, who is an advocate for economic growth, should reconsider the effects of climate change and see how addressing it could create vast economic growth opportunities by generating new businesses and millions of jobs in clean energy production.



Climate Change and the Economy



Angeles have already claimed 25 lives (17 in the Eaton fire and 8 in the Palisades fire) and are projected to cause damages amounting to \$250 to \$275 billion. More than 12,000 structures have been destroyed, and it is now considered one of the largest and deadliest wildfires in U.S. history.

In Pacific Palisades alone, California has reported damage or destruction to 5,316 structures. These numbers are expected to rise as the fires continue at the time of writing.

Those who consider climate change a hoax cannot deny the many undeniable facts based on decades of research and clear evidence, including the melting of ice sheets and glaciers, rising sea levels, changes in plant and animal behavior, and a nearly 1°C rise in global temperatures since 1880.

This seemingly small figure is economically significant; a 2017 study found that with every 1°C increase in temperature, the U.S. risks losing 2.3% of its GDP.

However, before we explore the potential for economic growth by developing new industries to address climate change, it is essential to focus on the massive losses and death toll caused by just six devastating events in the past four years, which occurred among many other climate-related disasters in the U.S.

In August 2020, Hurricane Laura was a powerful Category 4 storm that produced storm surges over 15 feet and historic wind speeds of 150 mph, the

s of January 14, 2025, the wildfires in Los strongest since 1856. It caused 42 deaths and \$28.1 billion in damages.

> From August to December 2020, massive firestorms in California, Oregon, and Washington resulted in 46 deaths and \$19.9 billion in damages. These fires wiped out several small towns and left millions suffering from poor air quality for months.

> In August 2021, Hurricane Ida took 96 lives and caused \$84.6 billion in damages. The storm spanned from Louisiana to New York and was ranked among the top five to seven costliest tropical storms.

> In February 2021, a historic cold wave and winter storm that affected most of the U.S. caused 262 deaths and \$27.2 billion in damages, making it the costliest winter storm in history. Texas was the hardest-hit state, accounting for most of the deaths (210).

> In September 2024, Category 4 Hurricane Helene hit Florida's Big Bend region with winds over 140 mph. This cyclone caused \$78.7 billion in damages and claimed 219 lives. It produced storm surges of over 15 feet and more than 30 inches of rain, resulting in severe flooding in western North Carolina.

> Finally, in October 2024, Hurricane Milton, which rapidly intensified from Category 3 to Category 5, claimed 32 lives and caused nearly \$35 billion in damages. It made landfall in Florida and spawned several tornadoes, further compounding the damage from Helene.

> These six climate-related storms, along with the Los Angeles fires, have led to 722 deaths and more than

\$523 billion in damages, along with the untold pain and suffering of thousands who lost loved ones and the hundreds of thousands who were forced into the arduous and expensive process of rebuilding their lives after displacement.

Although fires and storms are natural events and will continue to occur, climate change has intensified their severity and frequency, resulting in a higher death toll and billions spent on rebuilding efforts. Imagine if just half of the \$523 billion in damages from these disasters were invested in the clean energy industry—how many new clean energy businesses could have been created?

The time is long past when those who believe support a national initiative to invest hundreds of climate change is a hoax must understand that it is real and cannot be slowed or reversed on its own. In that he will back such legislation, provided there are

the future, climate change-related storms and fires will only increase, bringing with them trillions in costs and thousands of deaths.

Those who deny climate change must also realize that aggressive and sustained action to address it will not harm businesses, particularly in the fossil fuel and gas production sectors, but will do the opposite. It will generate new businesses dedicated to clean energy production, and oil and

gas companies can play a key role, for example, by managing renewable energy supply chains, thereby earning even more profit.

The United States has the resources and scientific knowledge needed to build new industries generating clean energy and expand existing ones. At this crucial moment, the incoming Trump administration should collaborate with states to provide federal funding for investments in clean energy industries.

This includes building iron-air batteries for longterm energy storage, producing green hydrogen, developing advanced nuclear technology (expected to play a key role in meeting rising electricity demand), massively expanding solar energy production capacity, boosting all new utility generation capacity, and constructing onshore and offshore wind turbine manufacturing facilities.

Finally, the manufacturing of electric cars and the development of more energy-efficient transportation can significantly reduce carbon emissions.

These efforts aim not only to keep the rise in global average temperature within 1.5°C above preindustrial levels, as outlined in the Paris Agreement, but also to create a dramatic increase in job creation. According to the World Economic Forum's 'Future of Jobs' report, new innovations will generate many job opportunities in clean energy sectors, not only offsetting the job losses caused by limiting the use of fossil fuels and gas but adding 78 million new jobs.

Given Trump's powerful political influence within the Republican Party and his unpredictable nature, he may change his stance, as he has done many times, and pass such legislation without facing serious opposition. In this context, he could count on the almost unanimous support of the Democrats.

Many would disagree and argue that, given Trump's public stance on climate change, there's no chance he will change his mind. Perhaps that's true. However, they should remember that Trump is not a rigid supporter of Republican ideology. He is not a radical, and he will adopt climate changerelated laws if they guarantee economic expansion and the creation of millions of new jobs, which are at the heart of his economic agenda.

Democrats have a new weapon to take on Trump: federalism

resident Trump has disrupted the traditional order of American politics to such an extent that it sometimes feels like the guiding stars we once relied on for political direction have fallen from the sky. In this topsy-turvy world, the ideas and organizations once deemed wholly negative have now become useful. One such example: Democrats and progressive legal scholars are revisiting federalism, the political theory which holds that powers not explicitly granted to the federal government are retained by the states.

Most Republicans have followed federalism and its promise of decentralized government; in fact, the Federalist Society played a crucial role in shaping the judiciary during Trump's first term. Even Trump - who wasn't one for relinquishing power used federalism to avoid responsibility when he decided to make abortion illegal. ("We sent it back to the states, and now... a lot of good things are happening," he said in a 2024 campaign video.)

For decades, federalism had been a curse for liberals, as "states' rights" were used to justify racial discrimination, block universal healthcare or same-sex marriage, and even, just a few years ago, reject vaccination or guarantine orders during the COVID-19 pandemic. But when Washington itself becomes hostile to civil rights and liberties, federalism could serve as a way to curb excessive governmental power. Yale Law School's Dean Heather Gerken argued, "Federalism has no political color. It can be a source of progressive resistance."

But this is not just about opposing Trump's agenda. Constitutional experts often note that federalism can be ineffective and lead to a divided government. But in these strange times, perhaps it is time to embrace division and use it in states to protect public health, civil rights, the environment, and democracy, where these treasures are still valued.

areas Trump has targeted, such as LGBTQ rights and gun violence protection.

Like during Trump's first term, Democratic states are preparing lawsuits to block or at least delay his sweeping orders. Trump's habit of steamrolling states and even Congress is already pointing toward a constitutional crisis. Just one day after his inauguration, 18 attorneys general filed a lawsuit in Massachusetts to block Trump's efforts to revoke citizenship for U.S.-born children of immigrants a guarantee under the 14th Amendment. Campbell is leading this lawsuit and recently told the Globe, "We have the tools to fight any threat, and we are not afraid to use them."

In fact, a U.S. Supreme Court case, initially lamented by liberals, may now help strengthen progressive state actions. In June, the Court overturned the so-called Chevron decision, which had directed courts since the 1980s to side with federal agencies when Congress failed to provide clear guidance (for instance, when the Environmental Protection Agency tries to enforce environmental regulations). The June decision's reasoning—that the federal government cannot "order" states to enforce vague federal rules—diminishes the power of the executive branch, i.e., Trump.

The Purpose and Development of the Quad

The Quad was formed in 2007 when India, Japan, Australia, and the U.S. came together to provide relief efforts in the Indian Ocean after the 2004 earthquake and tsunami. However, regional security, particularly China's growing military

He has repeatedly stated that India's interest lies in becoming not

India and U.S. Cooperation in the Context of China

The purpose of the Quad is to counter China's growing aggression, particularly in strategic areas like the South China Sea and Taiwan. During the Trump administration, the U.S. viewed India as an essential partner. S. Jaishankar, expressing his views, stated that India should form strategic partnerships with global powers to curb China's rising influence.

Trump was very clear about his tough stance on China, referring to it as an "official adversary" and a "threat." U.S. Secretary of State Marco Rubio, who had always held an aggressive stance towards China, furthered Trump's approach by portraying China as a serious threat. He made several harsh statements

This policy aimed at increasing U.S. influence abroad but also led to dissatisfaction in relationships with several countries. For India, this was a challenge, as there were imbalances in trade relations with the U.S., and the Trump administration had repeatedly threatened to raise tariffs.


However, S. Jaishankar tried

India, while understanding the U.S. 'America First' approach, also worked to boost its cooperation with the U.S. both economically and strategically. The Indian Foreign Minister clarified that India's goal was not just to agree with the U.S. perspective on China but also to present India's viewpoint on global issues.

Quad and International Security

The Ouad was formed to counter China's growing influence. In a joint statement, the four member countries expressed opposition to any unilateral



China has repeatedly accused the Quad of attempting to create an "Asian NATO," which is a misunderstanding. The Quad is not a military alliance but a platform to enhance diplomatic and strategic cooperation between countries. S. Jaishankar has expressed that the goal of the Quad for India is to promote peace and security, not escalate military conflicts.

The growing diplomatic relations between India and the U.S., especially under the Trump administration, have become significant in the context of the Quad and South Asia. It is necessary to shed light not only on India-U.S. relations but also on issues concerning Pakistan and Bangladesh, which hold central positions in South Asia's security, economic, and diplomatic dynamics.

Quad and the Context of Pakistan-Bangladesh

Although the primary objective of security and strategic cooperation under the Quad is to challenge China, its impact also extends to countries like Pakistan and Bangladesh, which are significant in the political and security context of South Asia. Pakistan's position has always been contentious from the perspective of the Quad. As a close ally of China, Pakistan has repeatedly accused the Quad of attempting to encircle China and create a negative diplomatic atmosphere against it. For Pakistan, this poses a challenge to its security and regional power, as the military and strategic strategies of the Quad directly conflict with Pakistan's security policies.

Relations between Pakistan and the United States have never been straightforward. During the previous Trump administration, pressure was applied on Pakistan, especially when the U.S. urged Pakistan to take action against terrorists. The growing cooperation between the U.S. and India worried Pakistan, as their relationship challenges the alliance between China and Pakistan.

Bangladesh, which is known as a major neighbor and

friendly nation of India, has seen its friendly relations with India deteriorate over the past six months, creating a tense situation. The geographical location of Bangladesh and the Islamic extremist activities within the country are not only affecting its minority Hindus, Buddhists, and Christians, but also its relations with India. As a result, the economic development processes, which were being facilitated by cooperation with India, the U.S., Australia, and Japan, have been deeply affected. Bangladesh has established strategic ties with China through close trade and infrastructure projects, such as Chinese investments in Bangladesh and inclusion in the Belt and Road Initiative. This contradicts India's interests. Bangladesh has thus far remained neutral toward the Quad, but the growing relationships with India and the U.S. could influence Bangladesh's diplomatic policies. For Bangladesh, maintaining relations with China holds significance, but its relations with India and the U.S. are equally important for its internal and external security, as well as its economic outlook. Pressure will be mounted on Bangladesh for the restoration of a democratic government, with the interim government's chief advisor, Mohammad Yunus, potentially facing difficulties due to the strained relations between him and Trump.

U.S. and India's Policy toward Pakistan

The approach of both India and the U.S. toward Pakistan has been quite complex. India has consistently taken an aggressive stance on issues like terrorism and border security, while the U.S. has viewed Pakistan as a strategic partner. Under the Trump administration, the U.S. criticized Pakistan for being a haven for terrorists and expected concrete action against Pakistani terrorist organizations. Trump guestioned security and economic cooperation with Pakistan, leading to a decline in U.S. support for Pakistan.

India took advantage of this situation to strengthen its ties with the U.S. and isolate Pakistan on international platforms. India's diplomacy made it clear that to counter any regional challenges posed by Pakistan, it would need U.S. assistance.

After Donald Trump took office for a second term as president in 2025, significant changes were seen in India-U.S. relations. Trump's 'America First' policy gave a new direction to these relations, impacting issues such as trade, energy, immigration, and regional security between the two countries. We will discuss these issues in detail and analyze how India-U.S. relations evolved under Trump's administration.

TRUMP 2. **A New Direction in** Indo-U.S. Relations

Trump's nder administration, India took steps to simplify market access for U.S. companies. The main reasons for this change addressing included trade imbalances and avoiding the risks of 'competitive tariffs'. Trump had raised the issue of trade imbalance and supported the reduction of tariffs on goods imported from the U.S. India specifically planned to reduce import duties on agricultural products, highquality medical equipment, and luxury motorcycles, making it easier for U.S. companies to enter the Indian market. For example, Trump engaged with motorcycle manufacturers and suggested reducing import duties on luxury products in India. This led to an improvement in trade exchanges between the two countries.

This step was also beneficial for India as it increased the supply of U.S. products and reduced trade imbalances. However, despite these trade reforms, imbalances remained in some areas. Trump's 'America First' policy prioritized U.S. interests, and although tariffs were reduced in many sectors, reducing the U.S. trade deficit remained a priority.

Energy Sector Cooperation

Trump's decision to maximize production opened energy the door for new partnerships between India and the U.S. in the energy sector. Under Trump's administration, India planned to



increase its purchase of American oil and gas. With the increase in energy production in the U.S., India received a stable supply of American energy products, which proved helpful in meeting India's energy needs.

Most of India's energy needs are met through imports, and in this context, the increasing supply of U.S. energy products benefited India. Under Trump's administration, India expanded opportunities to import more crude oil and gas from the U.S. Additionally, India strengthened its energy infrastructure, opening new avenues for investment by U.S. companies.

As a result of this cooperation, energy trade grew, and India gained new guidance on its energy security. This cooperation in the energy sector proved significant under the Trump administration, as it boosted trade exchanges between the two countries.

Immigration and H-1B Visas

Immigration and visa policies also had a special relationship between Trump's administration and India. Trump adopted strict policies to curb illegal immigration to the U.S., and India increased cooperation with the Trump administration, especially in identifying and deporting Indian nationals illegally residing in the U.S.

The H-1B visa, which was important for Indian IT professionals, also underwent several changes under Trump's administration. Under Trump's approach, this visa became more challenging for Indian IT professionals, as Trump planned to tighten these visa programs. However, India clarified its stance and regularly negotiated on visa policies, aiming for improvements in

the visa process, although these negotiations continued for a long time between the two countries.

Joint Strategy Against China

Trump's administration devised a strong strategy in partnership with India to challenge China's growing influence. To counter China's aggression, India and the U.S. promoted cooperation among the Quad countries. Marco Rubio held meetings with the foreign ministers of India, Japan, and Australia to discuss measures to curb China's growing influence. Cooperation among the Quad countries brought a new depth to India-U.S. relations. TRUMP 2.0 **Broken Hopes of Afghan Refugees**

Due to decades of ongoing conflict in Afghanistan and the increasing influence of the Taliban, many Afghans were forced to flee their country. Many of them submitted their applications in the hope of resettlement in the United States and waited for years for the process to complete. However, when the Trump administration unexpectedly halted the visa process, these refugees' hopes were shattered. This decision has created an atmosphere of uncertainty and despair in the lives of many Afghan refugees temporarily residing in Pakistan.

Afghan students studying at an English school in Islamabad were stunned upon hearing the news that their American resettlement process had been halted. Previously enthusiastic and hopeful, these students are now submerged in disappointment and deep depression. Syed Hasib Ullah, a 20-year-old teacher who had also applied for resettlement in the U.S., says, "This was a terrifying moment for us. We had been waiting for three years, and now there is no hope left." These students and teachers had made several plans for their future, which are now hanging in the balance.

Challenges for Refugees

A student at an English school in Islamabad, who had hoped to study in the U.S., broke down in tears upon hearing the news. Due to Taliban rule in Afghanistan, she had to leave her education incomplete, and now with the stoppage of the U.S. visa process, her hopes for higher education are also fading. For these refugees in Pakistan, there is no legitimate way to work or pursue formal education, and the U.S. resettlement was their only hope.

Disappointment for Hundreds of Afghans

Between 10,000 and 15,000 Afghan refugees are awaiting Special Immigrant Visas (SIV) or refugee resettlement in Pakistan. Many of these people came here to escape the atrocities of the Taliban, but now they too feel helpless about their safety and future. This crisis worsened in 2023 when Pakistan expelled Afghans, stating its inability to accommodate them due to economic and security issues. Among these refugees are individuals who have worked significantly for the U.S., such as family members of American military personnel and development workers involved in U.S. projects.

Feeling of Betrayal

Fifty-seven-year-old Fatima, who has worked for decades on women's rights and development, now feels betrayed due to the sudden halt in the U.S. visa process. She says, "You supported us at that time and pushed us forward, so we worked with you. Now you are leaving us behind at a time when we need you the most."





Fatima is particularly concerned about her 15-year-old daughter's education, who has been out of school for several years. Additionally, she hopes her 22-yearold daughter can complete her engineering studies.

Impact of the Message

Trump's order has not only deeply wounded the morale of the refugees but has also raised guestions about U.S. policies. Despite spending billions of dollars on military interventions and development projects in Afghanistan, there is now an inability to assist those who worked with American forces and defended their interests. Hasib Ullah said, "We helped you, and now we expected help from you."

Human Rights and Ethical Responsibilities

This tragedy of Afghan refugees brings back questions about human rights and ethical responsibilities in global politics. Afghan refugees living in Pakistan are not only grappling with an economic crisis but are now losing their hopes for a secure future. The safety and resettlement assurances they were given under U.S. policies have now become an unfulfilled dream for them.

30 Dead in Maha Kumbh Stampede

A stampede that occurred around 2 a.m. on the day of Mauni Amavasya at the ongoing Maha Kumbh in Prayagraj has led to a major tragedy. Reports indicate that more than 30 people have lost their lives, and many others have been injured. Prime Minister Narendra Modi expressed his grief over the incident and extended condolences to the families of the deceased. The stampede occurred on Mauni Amavasya, which is one of the holiest days for devotees at the Maha Kumbh. It was estimated that around 100 million people would visit the confluence (Sangam) for a dip on this day. Due to the belief in the significance of taking a holy dip at the Sangam, a large number of devotees gathered at the riverbanks. This tragic incident has raised serious questions about the safety and crowd management at the Maha Kumbh. Once the remaining complex maneuvers are completed, the foundation for achieving our space objectives will be even more solidified.

There is no doubt that without the success of this mission, it would have been difficult for India to send human passengers into space via Chandrayaan-4, Mars Orbiter, or Gaganyaan, establish and operationalize its own space station, collect samples from the Moon or other planets, or launch multiple rockets into space—especially for large space missions. The success of this test has made it

Last year, ISRO not only released its roadmap for the next 15 years but also publicized plans for 2040-2047. These include the second human flight of Gaganyaan in 2026-27 and the third human flight in 2028-29. The plan is to send three human-rated spacecraft by 2029, and after assessing their success and making necessary improvements, the final Gaganyaan mission—LUPEX—will send astronauts into space and return them in 2030. By 2035, ISRO plans to build its own space station with five modules, the first of which will be launched in 2028, followed by the others. The ability to dock these modules together in space will be made possible with this technology. This technology will also be necessary for creating the space station and facilitating travel to and from it, along with delivering supplies from Earth. ISRO has also prepared plans to land an Indian robotic humanoid on the surface of the Moon in 2037-38. In 2040, ISRO plans to send a manned spacecraft to the Moon, making the first Indian footprint on its surface, and safely landing the crew module in the ocean afterward. To send astronauts to the Moon or to bring back lunar samples through the Chandrayaan-4 mission, it will be necessary for one spacecraft to dock and undock with another in space. Hence, this technology is essential for achieving that goal as well.

Due to congestion in space, the Spacex launch on the night of December 30 was delayed by two minutes, as there were

achieve these space ambitions. After this technological breakthrough, the ability to fix any malfunction in a satellite while in orbit and to refuel any spaceship in space will also become possible. This success will enhance ISRO's confidence and pave the way for interplanetary missions, advanced space explorations, future moon missions, and human migration between planets.

The private company Starlink's 7,000 communication satellites are expected to increase to 12,000 soon, while thousands of others are inactive and have become space debris. The Spacex test may provide a solution to this problem of space debris. Through its satellite robotic arm, a satellite or cube set can be grabbed and pulled in, not only correcting the orbits of drifting satellites but also removing debris from inactive satellites. During the Spacex mission, several specialized tests will be carried out in real-world conditions, such as a performance test on the docking mechanism to test the final phase of docking, the Vertical Docking Experiment Laboratory for testing the docking system in controlled conditions, and the Rendezvous Simulation Lab with real-time simulations to check its algorithms. Additionally, new sensors that take precise measurements, like the laser range finder, rendezvous sensor, and docking sensor, will be tested. A new processor will also be tested during this mission. Along with ISRO's 14 payloads, 10 payloads from non-governmental organizations, startups, and academic institutions will conduct experiments on space radiation and microgravity. The data collected from these experiments over the next two years will help in developing autonomous systems for future missions. For the first time, a

multispectral payload will be used for monitoring natural resources and vegetation, with eight lobia seeds grown as part of a biological experiment, to measure plant growth.

On December 30, 2024, ISRO had planned to join two satellites in low Earth orbit with one acting as the target and the other as the chaser on January 7. However, it was delayed. Then, on January 9, technical issues caused another delay in the docking, and by January 12, after bringing the two spacecrafts within 3 meters of each other, they were safely moved back to a secure distance. At that point, it was speculated that the docking would only be possible in March. However, ISRO made history by successfully docking the spacecrafts, controlled from Earth, at an altitude of 470 kilometers, with the satellites traveling at nearly 28,800 kilometers per hour, almost ten times the speed of a bullet. The remaining task is to transfer electrical power and then undock the spacecrafts. One of ISRO's key future objectives is to develop a reusable rocket before 2047. Given the progress ISRO has made, this success seems inevitable. This achievement not only demonstrates India's growing strength in the field of space but also. provides a solid foundation for the country's future space ambitions. This is especially important at a time when space has become a new domain of global geopolitical competition, with rising rivalry.
